Perpetual Licensing

Perpetual licensing is the purchased right to use the software product for an **indefinite period of time** with the proviso that the user abides by the rule and restriction governing the use of the software outlined in the End User license Agreement.

Lease Licensing

Lease licensing is the purchased right to use the software product for a **limited period of time** with the proviso that the user abides by the rule and restriction governing the use of the software outlined in the product's End User license Agreement.

Perpetual licensing cost more than lease licensing at its commencement. The upgrade and maintenance agreement for a perpetual license is lower than a lease license renewal.

Lease licensing cost less than perpetual licensing at its commencement. The renewal cost of a lease license is higher than a perpetual license renewal.

There is no difference in the software being provided through each agreement. The only differences in these agreements are the cost and the term of usage.

Purchasing a software license is a three-step process:

- Step 1: Fill out our online order form.
- Step 2: After receiving your order we will send you our Software License Agreement (SLA) by mail to sign by your contract manager.
- Step 3: After receiving a signed copy of our SLA (by fax, mail or post) we will send you a license activation code (LAC) to unlock the software together with the invoice (Net30) by mail.
